Introduction

The conference is organized by the Arab Open University (AOU) headquarter in Kuwait in collaboration with the Regional Center for Development of Educational Software (RedSOFT).

Guidelines for Full and Short Papers

The 1st AOU International Conference on Open Learning invites scientists, researchers and specialists in open learning to submit papers that represent a new addition to the field (unpublished papers). Authors should submit their papers in accordance with the specified 1st AOU International Conference on Open Learning template downloadable from the conference website. In general, authors should adhere to the following requirements for their submissions:

- **Full Papers** These include mainly accomplished research results and have 15 pages at the maximum (15,000 words). Refer to the guidelines for preparing the papers.
- Short Papers These are mostly composed of work in progress reports or fresh developments and have 6 pages at maximum (6,000 words). Refer to the guidelines for preparing the papers.
- **Posters** These present results from projects and processes and procedures used in open and distance learning. Submit a one-page description of the poster.

The papers should be prepared in Microsoft Word format. Papers can be submitted in English or Arabic. The author(s) should provide a title, the name(s) of the author(s), author affiliation(s), address(es), email addresses, and three keywords

Font type

1. The text should be in Times.

Title

2. The title of the paper should be 14-point, in capital and lower case letters, and centered.

Author information

- 3. Use 10-point for the author name(s), 9-point for affiliation(s) and mailing address(es), and 8-point for email address(es).
- 4. The naming convention, with given names preceding surnames, should be used.
- 5. The author information should appear below the title, with one blank line after the title.

Abstract

6. The abstract submitted with the full and short papers should be between 100 and 150 words and should appear at the beginning of the paper. It should be 9-point. There should be two blank (10-point) lines before and after the abstract.

Keywords

- 7. Include three keywords.
- 8. The keywords should be 9-point and appear below the abstract, with one blank (10-point) line after the abstract.

Main text

- 9. Text throughout the paper should be 10-point Times, single space, and justified. Italic type may be used to emphasize words in running text.
- 10. Headings should be in capital and lower case letters (i.e., nouns, verbs, and all other words except articles, prepositions, and conjunctions should be set with an initial capital) and should, with the exception of the paper title, be aligned left. The font sizes for headings are as follows.

Title (centered) - 14 point, **bold** 1st-level heading - 12 point, **bold** 2nd-level heading - 10 point, **bold**

3rd-level heading - 10 point, italic

- 11. One blank line should appear between the parts of the paper (i.e. introduction, literature review, methods and procedures, results, conclusion, references).
- 12. Abbreviations should comply with the standard use. They should be given in full format at the first place they are used.

Tables and figures

- 13. Tables should be numbered and have captions which appear above them.
- 14. Figures should be numbered and have captions which appear under them.
- 15. Captions should be 9-point.

References

- 16. The author (date) method of citation in the text should be used. For example, Ali (2012) proposed or According to Hameed (2011).
- 17. All references that are cited in the text must be provided in the reference list. The references must be in APA format and arranged alphabetically at the end of the paper.

Paper Submission

Papers should be submitted electronically through the conference website <u>http://col.aou.edu.kw</u> or emailed to the Scientific Committee at <u>col@aou.edu.kw</u> <u>no later than May 31, 2013</u>. Authors will be notified of the acceptance of their papers and comments or modifications required <u>no later than June 30, 2013</u>.

Review Process

The papers submitted to the conference must be the authors own contributions and have not been copied in whole or in part from other works. Each submission is anonymously reviewed by an average of two independent reviewers, to ensure the high standard and quality of each accepted submission.

Conference Award

The 1st AOU International Conference on Open Learning: Role, Challenges, and Aspirations Higher Organizing Committee will present awards for the best three scientific papers submitted on one of the themes of the conference, in accordance with the following criteria:

- Paper's relevance for one of the current open learning problems.
- Paper's originality and excellence with regard to the development of optimal solutions for open learning systems.
- Paper's clarity and precision of expression, information and results obtained.

The value of the awards will be as follows:
